Die HORNBACH Holding AG & Co. KGaA (die „**Gesellschaft**“) hat den Beginn ihres Rückkaufprogramms zum 11. Juli 2022 durch Bekanntgabe gemäß Art. 2 Abs. 1 der Delegierten Verordnung (EU) 2016/1052 am 8. Juli 2022 mitgeteilt.

Im Zeitraum vom 11.07.2022 bis zum 19.10.2022, jeweils einschließlich, wurden insgesamt 55.000 Aktien der Gesellschaft im Rahmen des Rückkaufprogramms erworben.

Damit wurde am 19.10.2022 der Rückkauf eigener Aktien abgeschlossen.

Der Erwerb der Aktien erfolgte durch die von der Gesellschaft beauftragte COMMERZBANK Aktiengesellschaft ausschließlich über das XETRA-Handelssystem der Frankfurter Wertpapierbörse.
