Die HORNBACH Holding AG & Co. KGaA (die „**Gesellschaft**“) hat den Beginn ihres Rückkaufprogramms zum 10. Juli 2023 durch Bekanntgabe gemäß Art. 2 Abs. 1 der Delegierten Verordnung (EU) 2016/1052 am 7. Juli 2023 mitgeteilt.

Im Zeitraum vom 10.07.2023 bis zum 11.08.2023, jeweils einschließlich, wurden insgesamt 55.000 Aktien der Gesellschaft im Rahmen des Rückkaufprogramms erworben.
